

DECLARATION OF PROTECTION OF PERSONAL DATA

By granting consent to the processing of personal data, the person concerned agrees that the operator, company EVERGREEN sro, will process its personal data according to the following conditions.

Definitions

For the purposes of these conditions:

"Operator" company EVERGREEN, sro, Štiavnická cesta 8, 034 01 Ružomberok., Slovak Republic, Registration number: 36003131, e-mail: info@evergreen.sk, www.evergreen.sk,

"Person concerned" means a person who provides the Operator with their personal data for the purposes listed below, particularly, a visitor to the operator's website, a customer of the operator,

"Regulation" Regulation of the European Parliament and the Council (EU) No. 2016/679 of 27 April 2016, the General Data Protection Regulation (GDPR).

Legal basis of processing

The legal basis for processing is the consent of the person concerned and the fact that the person's personal data is necessary to fulfil the purpose of sending advertisements and newsletters.

Obligation to provide personal data and consequences of the consequences of not providing personal data

Personal information is provided on a voluntary basis by the person concerned and the person does not have any obligation to provide them. If the person concerned does not provide personal information, no advertisements or newsletters will be sent.

Scope of processing

An operator will process the personal information of the person concerned to the extent (e-mail address) the person provided it when accepting the subscription of the email newsletters.

Personal information provided to the operator for marketing purposes is processed by the operator through MailChimp application (www.mailchimp.com) to create, manage, and send newsletter campaigns to e-mail addresses.

Purpose of processing

The operator will process the personal data of the person concerned for the purpose of sending advertisements and information newsletters.

The period during which personal data will be processed

The operator will process the personal data of person concerned until their consent to their provision and processing is revoked, but for a maximum of 5 years.

Revocation of consent

Voluntarily approved consent to process the personal data can be revoked by the person concerned at any time by a revocation link at the end of each newsletter or by sending a request to the operator's email: info@evergreen.sk

The revocation of consent does not affect the lawfulness of processing based on the consent given prior to its revocation.

Persons with access to personal data / recipients

Personal data of the person concerned will only be accessed by operator's technical staff and recipients that external marketing services and technical administration, creating, managing and sending email campaigns of the operator (MailChimp), and providing appropriate safeguards for the personal data of person concerned in accordance with this regulation.

Access to these data will only take place for as long as is strictly necessary and to the extent necessary for the provision of service and the fulfilment of legal requirements.

Technical administration, creating, managing and sending email campaigns is provided to the operator through MailChimp application. The personal data of the person concerned is the subject of a cross-border transfer to the U.S. through the mentioned application, operated by The Rocket Science Group LLC d / b / a MailChimp, which adheres to EU-US rules, Privacy Shield *Framework* and the *Swiss-US Privacy Shield Framework*.

Contact details of the operator

The person concerned may contact the operator through e-mail: info@evergreen.sk or in writing EVERGREEN, sro, Štiavnická cesta 8, 034 01 Ružomberok.

An operator is entitled to require identification of the person concerned in order to prevent unauthorized access to personal data.

Personal data protection rights

In particular, the person concerned has the right to require from the operator access to his or her personal data, their correction or deletion, or limitation of processing, the right to object to the processing, the right to transfer the data to another operator, as well as the right to submit a complaint to the supervisory authority if the Operator proceeds with the processing personal data in violation with the regulation.

The right to object

The person concerned has the right to object to the processing of personal data, and the objection must be submitted to the operator. If the person concerned opposes the processing of personal data, the operator will not continue to process the personal data in such extent.

Right to file a complaint

The person concerned has the right at any time to submit a complaint to the supervisory authority regarding the processing of personal data or the failure of the operator to comply with the obligations of the regulation.
